## *About the Trust*

The Summerfield Charitable Trust was established by Ronald Summerfield, a Cheltenham antique dealer, shortly before his death in 1989. The Trustees have discretion as to which charitable uses to apply the funds.

In 2005 £356,895 was distributed in a total of 70 grants, from £500 upwards. A copy of the latest Trust accounts is available upon request.

**Charities applying to the Trust must either be based in Gloucestershire or they must be engaged in a project that is of specific benefit to residents of the county.**

### **Viewed especially favourably are projects and organisations working in:**

- The arts, museums and the built heritage;
- The environment and natural heritage;
- Community work;
- Education, sport and recreation;
- Vulnerable or disadvantaged sectors of society.

### **THE TRUSTEES ENCOURAGE APPLICANTS TO SHOW THEY HAVE CONSIDERED:**

- The impact of their project on the environment;
- Planning for long term self sufficiency;
- The potential to work in partnership with other statutory and non-statutory funders;
- Their active involvement with the people who will benefit.

**Individuals are very rarely supported.** They must be residents of Gloucestershire. Trustees request individuals to use a specialist charity to sponsor their application.

### **Donations are not given to:**

- medical research;
- private education;
- animal welfare appeals;
- fund trips abroad;
- projects that have already taken place.

**PROCEDURE:** The Trustees meet quarterly - usually in January, April, July, and October - to consider all applications received prior to the deadline dates (5<sup>th</sup> December, 5<sup>th</sup> March, 5<sup>th</sup> June and 5<sup>th</sup> September). These dates are occasionally subject to change.

**TO APPLY:** Applicants must log on to our website to view information about eligibility for funding and download a copy of the current guidelines and a grant application cover sheet. **A cover sheet must be completed and returned before an application can be submitted to the Trustees.** If you have any queries at any stage of the application process, you are welcome to email or telephone me. Please note that I often ask one of our independent advisers to visit organisations who apply to the Trust. I aim to inform applicants of the Trustees' decisions as soon as possible after the quarterly meetings. We do not accept faxed or emailed applications.

## *Introduction*

During 2005 the Summerfield Trust donated £356,895 to a wide variety of good causes. In line with our stated policy these grants were made exclusively to beneficiaries based in Gloucestershire. In this report there is a detailed analysis of the grants, and this highlights the varying sizes of the grants.

During the year we undertook a major strategy review. Our administrator, Lavinia Sidgwick consulted a large number of organisations across the whole county, including the County Council, Social Services, other grant-makers and beneficiaries in order to try to identify areas of unmet need, and potential projects and initiatives where we could make a real difference. The outcome of this review is reflected in our revised guidelines. We continue to encourage as diverse a range of applicants as possible, and we are keen to be involved in projects, both large and small, that are imaginative and to which we can make a significant contribution.

We conducted a review of our investment strategy in conjunction with our advisers. There has been a substantial rise in the value of our investments. We also reviewed our operating procedures, and simplified them as much as possible.

We continued to give substantial support to the Arts, and during the year we gave a further £20,000 to Brewery Arts in Cirencester for them to develop their site in the town as artists' studios, workshops and exhibition space. The 2004 Rome scholar recipient, Lily Musker delivered her commissioned portrait of three of the trustees, which is now part of the Summerfield Collection, currently hanging in St. James' House in Cheltenham. We also changed the nature of our annual grant to Cheltenham Arts Festivals. Instead of making a general donation towards all four Festivals, the trustees agreed a two year grant with the possibility of a third year, to fund the salary of a specific Education Manager to be responsible for education and outreach for all the Festivals.

The trustees are greatly helped in assessing applications by our team of volunteer advisers. We held a successful seminar day with the advisers, including a workshop in understanding accounts from our accountants Buzzacott. The trustees also met with Buzzacott in order to review the new SORP 2005 reporting regulations, and this is reflected in our annual accounts.

The wide range of applicants creates a demanding level of understanding for the Trustees, combined with an ability to decide on the relative merits of different projects in different fields. They are greatly helped in this by our team of volunteer advisers, our administrator, Lavinia Sidgwick, and by our secretary, Tracey Price. Sadly Tracey has decided to retire in May: we are grateful for her skilful help, and wish her well in the future.

Finally I would like to thank my co-trustees for the generous allocation of their time. They are all busy people with their own careers and yet they find the time to do this work with unfailing good humour. They help to make Gloucestershire a better place.

## *About the Trustees*

### **CHARLES FISHER**

Charles Fisher went to school in Cheltenham, and then graduated from Oxford University. He has pursued a career in business and was Chairman & Chief Executive of Sharpe & Fisher plc from 1989 to 1999. He is currently Chairman of a number of major companies. He was also the Chairman of Cheltenham Arts Festivals Ltd from 1990 to 1995. He became Chairman of the Trustees in 1999.

### **JAMILA GAVIN**

Born in India, Jamila Gavin has lived in Gloucestershire for over thirty years. First a piano scholar at Trinity College of Music, London, then in Paris, she finally joined the BBC and worked as P.A. Director for Music and Arts on Television. On moving to Gloucestershire she turned to writing children's books, and has since produced numerous stories and novels for the whole age range, as well as plays for the stage, radio and television. She was runner up for the Guardian Children's Fiction Award, has been shortlisted for numerous other awards, such as The Smarties Prize and the Carnegie Award, and was winner of the Whitbread Children's Book of the Year Award in 2000.

### **GILBERT GREENALL**

Gilbert Greenall served in the army after going to Sandhurst. He subsequently trained as a doctor and was Senior House Officer at Cheltenham General Hospital. Since 1979 he has specialised in humanitarian emergencies and post conflict recovery, and is a member of the United Nations Disaster Assessment & Co-ordination team. He has led missions in many countries in recent years, including East Timor, Kosovo, Mozambique and Albania. He has also worked for the European Union and the Department for International Development.

### **JAN URBAN-SMITH**

Jan Urban-Smith has lived and worked in Gloucestershire for the last 26 years. She has been an English teacher, Head of Sixth Form and Deputy Headteacher. She currently works as an adviser for the Local Education Authority.

### **RICHARD WAKEFORD**

Richard Wakeford lives in Winchcombe and is a senior executive, with wide experience in rural and environmental issues. He is currently Head of the Scottish Executive Environment and Rural Affairs Department, having previously been Chief Executive of the Countryside Agency.

Brewery Arts is an established arts and craft centre in Cirencester. This was the second instalment of a grant agreed towards a major development appeal.

Since 2000 Cheltenham Artists Open Houses has run an event which facilitates artists to open their houses/studios to the public throughout Cheltenham and a surrounding 10 mile radius. SCT made a donation towards the 2005 publicity costs.

£3,000**

The Right Hon Chris Patten MP gave the Summerfield Lecture during the Literature Festival in 2005. He gave a stimulating insight into the uncomfortable menage-a-trois between Britain, America and Europe.

**COTSWOLD PLAYERS  
£10,000**

The Cotswold Players has been an active amateur dramatic society since the early 1950s. It is based in a converted chapel in Stroud and produces approximately four performances a year. In 2002 a major building programme was launched to improve facilities and SCT made a donation towards phase two of the refurbishments.

The Cirencester Early Music Festival is an annual, six day event during which local musicians play music from the Renaissance and Baroque periods. SCT contributed to the publicity costs.

CHURCH COUNCIL**  
£3,500

SCT awarded a grant for this PCC to install a new oak floor for the parish room, which is regularly used by local societies and community groups.

**BLAKENEY UNDER FIVES**  
£7,000

Donation towards an appeal for funds to help build new premises for a playgroup and nursery in this Forest of Dean village.

**CRUSE BEREAVEMENT CARE**  
£3,000

CRUSE offers a free counselling service and support groups for the bereaved. This branch is based in Cheltenham but counsellors visit clients throughout the county. It asked SCT to help with the purchase of equipment for training.

**GLOUCESTER CENTRE FOR  
VOLUNTARY SERVICES**  
£9,000

The Gloucester Centre for Voluntary Services was established in 1996 to act as a local development agency for the voluntary and community sector in the city. This donation was to help run training courses for volunteer management committee members and volunteers working at the Centre.

**GLOUCESTERSHIRE SOCIETY**  
£5,000

The Gloucestershire Society was established in 1657. Its function is to provide immediate grants to Gloucestershire residents "living at the edge of their resources". Individuals in need are recommended by Social Workers or Health Visitors. SCT made a general donation.

**HANDS AROUND THE WORLD**  
£2,500

This charitable trust aims to promote international understanding by enabling volunteers to offer practical help to disadvantaged areas of the world. SCT made a donation towards the purchase of a digital camera.

**INDIAN ASSOCIATION**  
£2,000

The Indian Association in Cheltenham was established twenty-four years ago to provide support to the local Hindu community, to promote their culture and to generate understanding within the town. SCT made a contribution to help with the refurbishment project.

**LISTENING POST**

Listening Post provides a free counselling service for those on low incomes. It requested help with the relocation costs of moving to new premises in Gloucester.

This charity is a Christian organisation established in 1985 to further the ministry of Christian healing. It is based in Harnhill Manor, a sixteenth century house, near Cirencester. SCT gave a donation towards the restoration appeal .

The World Land Trust is a charity working to protect and sustainably manage threatened habitats and endangered species. SCT gave a grant to support work being done in the charity's only British nature reserve, Kites Hill near Painswick.

**CARESHARE**  
**£5,000**

CareShare, based in Cirencester, provides flexible, home-based respite care to people with physical disabilities or dementia living in the Cotswolds. SCT awarded a grant to enable the charity to provide more care hours to families who have able bodied children as well as children with disabilities.

**CONDUCTIVE THERAPY  
CHELTENHAM**  
**£1,000**

SCT awarded a grant to help provide conductive therapy for people with Parkinson's Disease and Multiple Sclerosis.

**FRIENDS OF MILESTONE  
SCHOOL**  
**£500**

The Milestone school in Gloucester is one of the largest special schools in the country. It caters for children aged 2-16 who have a wide range of severe disabilities. SCT awarded a donation towards the costs of running a summer school.

**FRIENDS OF PATERNOSTER  
SCHOOL**  
**£525**

Paternoster School in Cirencester provides for pupils with severe and profound learning disabilities. SCT contributed towards the cost of a summer holiday for a group of the children.

**GUIDE DOGS FOR THE BLIND

SCT made a donation towards the costs of establishing a volunteer boarding scheme for guide dogs in advanced training in Gloucestershire.

**GUIDEPOSTS TRUST

This charity, based in Gloucester, organises discovery activities and cultural experiences which are especially tailored for those with a physical disability. This request was for help with the costs of an arts week, which took place on a canal boat during the summer.

Since 1969, the Home Farm Trust has been providing a residential and day service at the 'Old Quarries' near Nailsworth for those with learning disabilities. SCT made a donation towards the refurbishment of a second property which needed to cater for the increasing age and changing needs of four of the residents.

The James Hopkins Trust was established in 1989 in Gloucester to provide respite and nursing care to children under five with a severe disability or life threatening illness. SCT made a donation to support the provision of nursing care.

**LEONARD CHESHIRE HOME  
OF GLOUCESTERSHIRE  
£5,000**

The Leonard Cheshire Home in Cheltenham is a purpose built home for 36 permanent residents. SCT awarded a grant to help modernise the kitchens.

**M.S. INFORMATION &  
THERAPY CENTRE  
£1,000**

This Centre was set up in Gloucester in 1985 to offer various treatments to sufferers of Multiple Sclerosis, Cerebral Palsy and other disabling conditions. SCT made a donation to subsidise the cost of providing the therapies.

**MUSICSPACE TRUST  
£8,000**

This charity was founded in 1989 to provide education and social development of children and adults with special needs, through music therapy. The Gloucester branch applied for a contribution towards a project to develop their outreach work and to purchase more instruments.

**ST GEORGE'S ASSOCIATION  
£5,000**

St. George's Association in Cheltenham is a charity providing a range of services for adults with learning difficulties including residential care, supported living and day opportunities. The Waker Apartments offer accommodation for women who do not need 24 hour care, and SCT made a donation towards building a kitchen in the apartments.

**THOMAS MORLEY TRUST  
£10,000**

The Thomas Morley Trust was set up in 1994 to provide sailing opportunities for disabled people. SCT awarded a grant to help purchase two specially adapted dinghies for the use of Whitefriars Sailing Club at South Cerney.

**£11,500**

This school in Tewkesbury was raising funds to create a community centre for music and the performing arts. SCT awarded a grant to help build a drama room.

**CHELTENHAM ARTS  
FESTIVALS LTD**  
**£28,500**

SCT agreed to fund the new post of Education Manager for Cheltenham Arts Festivals for two years. This is in the expectation that the education work will become more central to all the Festivals' activities. It will have wider ranging and longer term benefits, and will be made available to a much larger cross section of the community.

**CHIPPING CAMPDEN  
FESTIVAL**  
**£770**

Chipping Campden Music Festival has been running for four years. SCT awarded a grant to help run music workshops in local schools.

**DIOCESE OF GLOUCESTER**  
**£3,000**

The Diocese of Gloucester Resource Centre was established in 1985 as a lending library for parishes and schools to assist with and promote religious education. SCT awarded a grant towards the purchase of appropriate textbooks.

**FRIENDS OF MINSTERWORTH  
PRIMARY SCHOOL**  
**£3,000**

This small village school was taking part in the Gardens for Life project, with the intention of informing children about healthy food and how to grow it. This was such a success that the Friends decided to raise funds to build an outdoor classroom.

**GLOBAL DIMENSION TRUST**  
**£10,000**

The Global Dimension Trust works with schools in the county to improve knowledge of global sustainability and citizenship. This was the second tranche of a grant agreed in 2004 to help develop a project linking trained volunteers from ethnic minority communities to work in schools.

**LUMBS EDUCATIONAL  
FOUNDATION**  
**£5,000**

This Foundation makes grants to young people living in Gloucestershire to help them further their education. This was the fourth grant SCT has made to LEF, to help increase the number of bursaries awarded.

**QUENINGTON SCULPTURE  
TRUST**  
**£1,000**

This Trust in Quenington, a small village near Cirencester, has run a biannual outdoor sculpture exhibition since 1999. SCT gave a donation to fund the costs of a specialised tutorial for seven art and design students from the National Star Centre.

**SHURDINGTON C OF E  
PRIMARY SCHOOL  
£1,700**

Shurdington primary school and playgroup were collaborating on a project to improve the play area in the school grounds. SCT made a contribution towards the building of a pirate ship.

The South Cerney Playgroup has been operating since 1969. An appeal was launched to raise funds to replace the portakabin in the grounds of the local primary school with a permanent structure.

## *Elderly*

**ART SHAPE LIMITED**  
**£20,000**

This application was the result of several discussions between SCT, Age Concern and ArtShape, to find a way of delivering a consistent programme of arts activities to a much wider range of older people who may not live in homes or attend centres. SCT agreed a two year grant to support the delivery of the New Horizons programme.

**BRITISH RED CROSS SOCIETY  
(GLOUCESTERSHIRE)**  
**£2,500**

The Red Cross works in partnership with Uplands day care service, providing transport to the centre for the disabled and elderly living in Stroud. SCT made a donation to help with the cost of the service.

**COTSWOLD VILLAGES OLD  
PEOPLE'S HOUSING  
ASSOCIATION**  
**£7,000**

This charity provides sheltered housing and a daily cooked meal to residents of Blockley, near Moreton in Marsh. This request was for funds to help refurbish the kitchens and bathrooms.

**QUEEN'S NURSING INSTITUTE**  
**£3,000**

SCT agreed to part-fund a pilot project researching the mobility needs of older people in care homes in West Gloucestershire.

**UPLANDS CARE SERVICE**

This service was set-up in 1994 to provide therapeutic day care for the disabled and elderly living in Stroud and the surrounding area. SCT made a grant towards the costs of the final phases of refurbishment.

**£3,000**

Charlton Kings Youth Club in Cheltenham was in urgent need of a new roof and windows.

**CINDERFORD AREA NEIGHBOURHOOD DEVELOPMENT INITIATIVE**  
**£5,500**

In 1995, SCT awarded the Cinderford Area Neighbourhood Development Initiative (CANDI) a grant to help establish a drop-in Youth Café. Since then, it has become an established facility offering a range of opportunities and support service to the young people of the town. SCT made a one-off grant towards the employment of two young people as trainee youth workers.

**CIRENCESTER CYBER CAFE**  
**£5,000**

The Cotswold Council for Voluntary Service helped a group of volunteers to set-up a Cyber Café for young people in Cirencester. SCT made a contribution towards the initial costs.

**FOREST OF DEAN MUSIC MAKERS**  
**£15,000**

SCT awarded a grant to help adapt and extend premises at Heywood School in Cinderford to create a music centre for young people.

**OASIS YOUTH PROJECT**  
**£4,500**

The Oasis Youth Project, based in Hester's Way, Cheltenham is specifically for children aged between 10-12 who have a learning disability and or problems at school. SCT agreed a grant to enable the Project to operate on two nights a week.

**TEWKESBURY SEA CADETS**  
**£2,000**

Tewkesbury Sea Cadets applied for a donation towards the cost of refurbishing the toilet block at their base in a Victorian schoolhouse.

**WINCHCOMBE PARISH P.C.C.**  
**£2,000**

SCT agreed a grant to help with the cost of providing accommodation for the student minister for a church youth project in Winchcombe.

**YOUTH OF ULEY PROJECT**  
**£2,000**

Residents of the villages Uley, Owlpen and Nympsfield started a youth club for young people aged between 11-16, and SCT awarded a grant to help purchase equipment.

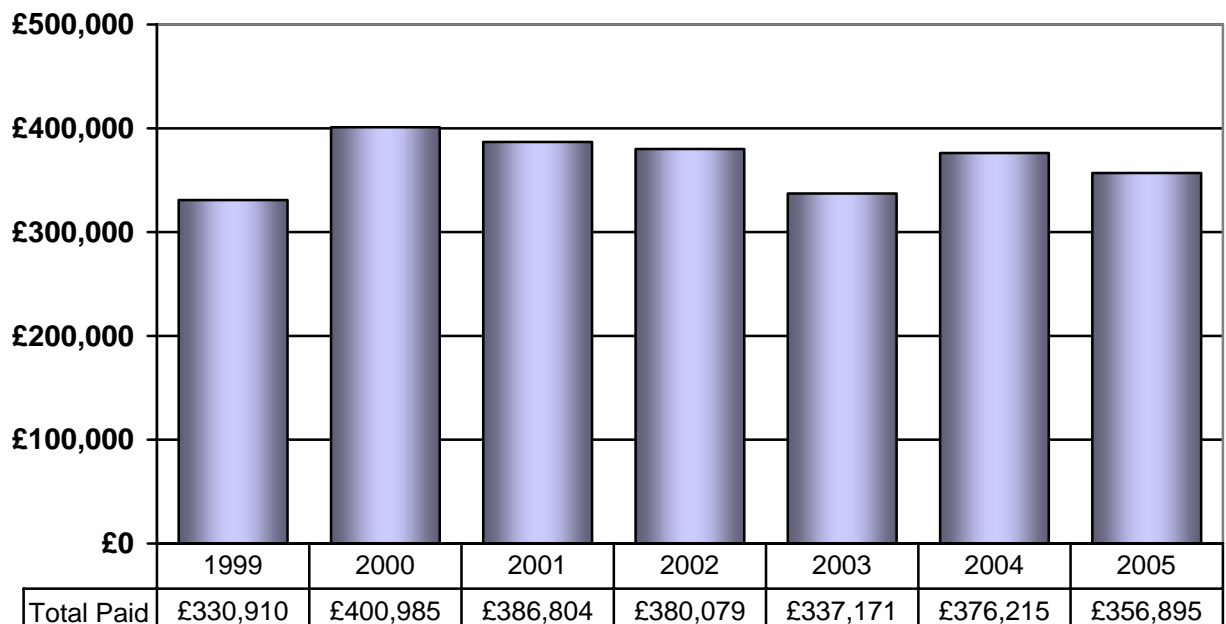

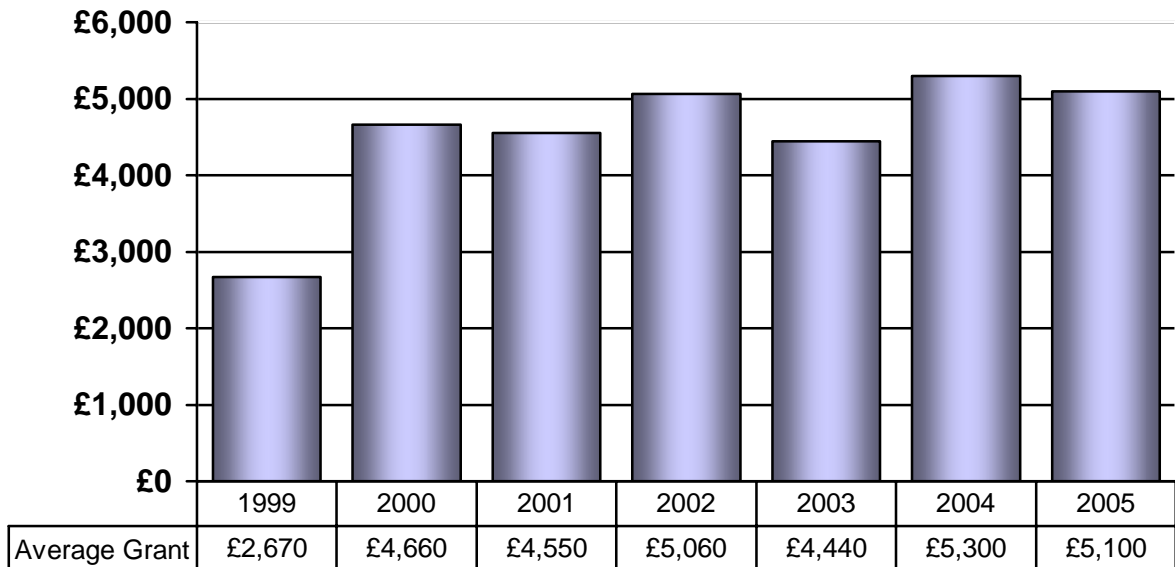
