About the Trust

The Summerfield Charitable Trust was established by Ronald Summerfield, a Cheltenham antique dealer, shortly before his death in 1989. The Trustees have discretion as to which charitable uses to apply the funds.

In 2010 £382,415 was paid in a total of 78 grants, from £150 upwards. A copy of the latest Trust accounts is available upon request.

Charities applying to the Trust must either be based in Gloucestershire or they must be engaged in a project that is of specific benefit to residents of the county.

Viewed especially favourably are projects and organisations working in:

- ☑ The arts, museums and the built heritage;
- ☑ The environment and natural heritage;
- ☑ Community work;
- ☑ Education, sport and recreation;
- ☑ Vulnerable or disadvantaged sectors of society.

The Trustees encourage applicants to show they have considered:

- ☑ The impact of their project on the environment;
- ☑ Planning for long term self sufficiency;
- ☑ The potential to work in partnership with other statutory and non-statutory funders;
- ☑ Their active involvement with the people who will benefit;
- \square The outcomes of the project or service.

Donations are <u>not</u> given to: Medical research; private education; animal welfare appeals; fund trips abroad; projects that have already taken place.

Appeals from churches: will <u>not</u> be considered in 2011. You are advised to apply to the Gloucestershire Historic Churches Trust.

Individuals: Applications from individuals are no longer accepted. Should an individual resident of Gloucestershire need financial support for <u>educational needs</u>, they are recommended to contact the Lumb's Educational Trust. SCT awards an annual grant to Lumbs to enable it to support residents of the county on SCT's behalf. Write to: Mrs Margaret Wanless, 4 Manor View, Cold Pool Lane, Up Hatherley, Cheltenham GL51 6HZ.

Charities which have been in receipt of a grant should not re-apply for at least two years unless they have specifically been asked to do so.

PROCEDURE: The Trustees meet quarterly - usually in January, April, July, and October - to consider all applications received prior to the deadline dates. These dates are occasionally subject to change and should be verified via our website or by email / telephone before you submit your application.

TO APPLY: Applicants should read the information listed on the website and download a grant application cover sheet. **A concise explanation of the application (no more than one side of A4) must be sent to me by email.** If appropriate, I will then encourage you to send a hard copy, which might have more detail, and any supporting documentation, to me at the address below.

Applicants are welcome to telephone and discuss queries with me before submission. Please note that I often ask one of our independent advisers to visit organisations who apply to the Trust. I aim to inform applicants of the Trustees' decisions as soon as possible after the quarterly meetings. All appropriate new applications are acknowledged: stamped addressed envelopes are welcomed.

Introduction

It is a privilege to succeed Charles Fisher as Chairman of the Summerfield Charitable Trust. Having lived in Gloucestershire for over 30 years and having managed the Racecourse since as far back as the auction of the artefacts of Ron Summerfield, in vast marquees, I am constantly reminded of the Trust's impact on our quality of life.

Charles made a quite outstanding contribution through a period in which the Trust supported a vast range of good causes in the county. Most recently, these enabled Gloucestershire Gateway Trust to gain planning approval this year for the innovative motorway services station and Cheltenham Art Gallery and Museum to make an application for funding for a redevelopment project befitting the $21^{\rm st}$ Century.

Richard Wakeford also retired as a trustee under the 10-year policy and we are enormously grateful for his contribution, particularly with regards to environmental applications. 'Green Day' at the Literature Festival was a fine example of Richard's creative thought.

During 2010, we welcomed Anthony McClaran and James Millar as new Trustees.

Our investments continued to improve during the year, under management by Smith & Williamson, ending the year comfortably above £9m. This bodes well for the immediate and medium term future as the Trust seeks to continue it's significant impact across the full scope of its grant-making categories and, if possible, maintain the value of the portfolio for the longer term.

During 2010 the Summerfield Trust paid £382,414 to a wide variety of good causes. We continue to encourage a diverse range of applicants and we are keen to be involved in projects, both large and small, that are imaginative and to which we can make a significant contribution.

We made a total of 78 grants as set out in this report. These include a significant grant of £30,000 for three years to the Nelson Trust to support their new women's centre in Gloucester and £30,000 to the National Star College towards their new work-skills centre. The Summerfield lecture was given by David Willetts on his thesis that the 'baby boomer' generation continue to reap the benefits of their age and are disbenefitting those born more recently, a subject that served as a reminder for the Trustees to discern need from want.

Cheltenham Art Gallery and Museum has kept the Trust appraised of progress with project fundraising. This lead to a deferment of the grant being approved by Trustees to prevent a commitment for temporary closure before full funding was secured. The University confirmed their decision to sell the Pittville campus and thus force the closure of the Summerfield Gallery in 2011. There is a continuing dialogue regarding the Trust's grant, which, it is hoped, will connect with the new Art Gallery.

We are an experienced and well-organized grant making charity, and we are keen to encourage anyone who wishes to donate or leave money to charity to consider using the Summerfield Trust as a suitable method for doing this. Our Trustees are not remunerated for the time and expertise which they give to managing the Trust.

I am very grateful to my co-Trustees, and to Lavinia Sidgwick, and to our volunteer advisers for their hard work and commitment. Sadly one of our most longstanding advisers, Lesley- Anne Sayers, died very unexpectedly in the spring. She had been a ballerina and then an academic and was passionate about the arts in all forms. She was a wise adviser to us for many years and we miss her imaginative reports and enthusiasm for the arts in Gloucestershire. Trustees agreed to award a donation towards a scholarship fund set up in her name to support the study of scenography.

At the year-end, Trustees were mindful that Local Authority funding cuts and financial difficulties being experienced by many charities are likely to make the legacy of Ron Summerfield ever more important to the life of Gloucestershire.

About the Trustees

JAMILA GAVIN

Born in India, Jamila Gavin has lived in Gloucestershire for over thirty years. First a piano scholar at Trinity College of Music, London, then in Paris, she finally joined the BBC and worked as P.A. Director for Music and Arts on Television. On moving to Gloucestershire she turned to writing children's books, and has since produced numerous stories and novels for the whole age range, as well as plays for the stage, radio and television. She was runner up for the Guardian Children's Fiction Award, has been shortlisted for numerous other awards, such as The Smarties Prize and the Carnegie Award, and was winner of the Whitbread Children's Book of the Year Award in 2000.

EDWARD GILLESPIE

Edward Gillespie was educated at Tonbridge School and the University of York where he gained a degree in Politics. He has managed racecourses since he was 21 and has been Managing Director at Cheltenham Racecourse since 1980. He is on the Jockey Club Racecourses Board and Chairman of the British Horseracing Authority Jump Racing Development Group. Since moving to Gloucestershire, he has served on the Cheltenham Festivals Board and is a Board member of The Everyman Theatre, which he chaired for ten years. He chairs Gloucester Cathedral Council and the Board of Gloucestershire Tourism. He is an Honorary Fellow of the University of Gloucestershire, a Deputy Lieutenant of Gloucestershire and an Honorary Freeman of the Borough of Cheltenham.

ANTHONY McCLARAN lives in Cheltenham. He took up post as Chief Executive of the Quality Assurance Agency on 1 October 2009, after nearly six years as Chief Executive at UCAS. He is a director of the Inspiring Futures Foundation, and was recently appointed Chair of the new All Saints Academy in Cheltenham. Anthony also sits on the Board of the Gloucestershire Development Association. He is a Fellow of the Chartered Management Institute, a Freeman of the Company of Educators and a member of the Honourable Company of Gloucestershire.



Figure 1: TOTAL GRANTS PAID - 10 year pattern






Figure 3: NUMBER OF GRANTS PAID – 10 year pattern
